

Summer Work & Travel Ambassadors Program

The U.S. Embassy Bratislava is pleased to invite university students to apply for the **Summer Work & Travel (SWT) Ambassador Scholarship program**. The SWT Ambassadors Program is a scholarship add-on to the regular Summer Work & Travel exchange program. Timing and all conditions of the regular program apply; please find more information at www.letovamerike.sk. Participants attending universities in Slovakia are allowed to work in the U.S. between May 15th and September 15th for a maximum of 120 days and must return to Slovakia by the beginning of the fall semester at their universities. The program is implemented in cooperation with Camp Leaders ([website](#)) and CKM ([website](#)).

The Embassy Committee will select candidates approximately every two weeks from pool of applications. Candidates who are eligible for the program will stay in the pool until the process closed after the final round of selection.

PROGRAM DESCRIPTION

The Summer Work & Travel Ambassadors Program is a scholarship add-on to the regular cycle Summer Work & Travel Program, which means all requirements, restrictions and benefits of the SWT program apply.

The Summer Work & Travel Program provides foreign students enrolled in college or university with an opportunity to live and work in the United States during their summer vacations. Jobs are seasonal in nature, mostly related to the hospitality industry, and are located across the United States. The program runs 3 to 4 months; participants attending universities in Slovakia are allowed to work in the U.S. between May 15th and September 15th for a maximum of 120 days and must return to Slovakia by the beginning of the fall semester at their universities. Please note: Summer Work & Travel is not for visitors who are only interested in tourist travel in the United States; participants must commit to the work portion as well. In summer 2023, 246 students will have the opportunity, for only the cost of a U.S. visa or visa interview fee and/or SEVIS fee (and otherwise free of charge), to experience the United States as thousands of American college students do during their own vacations. Ambassadors will have the opportunity to travel at the end of their work program in order to learn first-hand about different parts of the country so as to show the real United States to their friends, colleagues, and followers, and positively shape how Slovaks view the U.S. while combating misperceptions. There will be 206 slots open for various jobs at summer camps through Camp Leaders and 40 slots for other job opportunities (e.g hotels, restaurants, amusement and water parks, resorts etc.) through CKM.

SWT Ambassadors will be asked to have and to present a plan to promote their own experiences and the SWT program upon their return to Slovakia. The U.S. Embassy in Bratislava will facilitate a pre-departure orientation seminar/webinar for participants with experts from the field of outreach and marketing.

The Summer Work & Travel Ambassadors program is open to Slovak citizens or permanent residents of the Slovak Republic who speak and work fluently in the Slovak language. The Embassy and/or

implementing agencies might ask for proof of proficiency in Slovak language. The program is open to university students in Slovakia.

All program costs except for the visa or visa interview fee and/or SEVIS fee (\$195 in total) will be covered by the U.S. State Department, Bureau of Cultural and Educational Affairs, and the U.S. Embassy in Bratislava. The program will be implemented by two Summer Work & Travel agencies and participants will be notified which will be their implementing agency.

CANDIDATE PROFILE

Summer Work Travel Ambassadors must:

- Be sufficiently proficient in English to successfully interact in an English-speaking environment and/or willing to improve their language skills. Participants with lower proficiency are encouraged to use online translators for their application, as one of the goals of Summer Work & Travel program is to improve the language skills of participants.
- Be a post-secondary school student enrolled in and actively pursuing a degree or other full-time course of study at an accredited classroom-based, post-secondary educational institution in Slovakia.
- Have successfully completed at least one semester or equivalent of post-secondary academic study.
- Plan on continuing their university education in the next academic year after return (i.e. cannot be in the final year of study).
- Demonstrate their commitment to promote the program in the future.
- Be willing and able to fully participate in the program.
- Be willing to adhere to the terms and conditions stated by the Department of State and implementing agencies.

The Summer Work & Travel pool of 246 participants will be gender and regionally balanced. Summer Work & Travel Ambassadors from marginalized communities and/or economically disadvantaged backgrounds and/or first-time applicants for SWT Program will be prioritized. Preference may also be given to students who are demonstrably active within their own communities/online since the goal of the Ambassadors program is to reach a wide audience. The SWT Ambassador program is not open to final year students.

Participants will travel to the United States on J-1 visas. It's recommended that participants arrive in the U.S. at least 5 days prior to the start date of their program, and they cannot arrive more than 30 days early or to remain in the U.S. more than 30 days after its end date. Violations of program rules, SWT agency rules, or local, state, or federal laws can be grounds for immediate dismissal from the program.

FAQ

Do I need to have permanent residency in Slovakia?

Yes, the program is only open for permanent residents and citizens.

Will you select candidates from my university as well?

Yes, the pool of Ambassadors will be regionally balanced so we are looking for students from all over Slovakia.

Can I travel earlier than May 15?

No, this date is the earliest possible date when you can enter the U.S. You can, however, leave for the U.S. later once you have successfully finished your academic year.

How can I demonstrate my plan for promotion?

This plan will be up to you – it can be anything you can think of, from posting on social media to giving an interview for your school media outlet to hosting community events for your peers.
